

# TERRY COLLEGE OF BUSINESS BBA MAJOR ADMISSIONS PROCESS

All University of Georgia (UGA) students who plan to pursue a Bachelor of Business Administration (BBA) degree are initially admitted to the Terry College of Business as intended-business majors. Students can apply to a Terry major once they meet all application eligibility requirements, typically during their second year at UGA.

**BBA Major Options:** Accounting, Economics, Finance, Management, Management Information Systems, Marketing, Real Estate, and Risk Management and Insurance. The **International Business co-major** is offered in conjunction with other Terry BBA majors. Applicants must select both a first- and second-choice major; ACCT, FINA, MARK, and MIS are not available as second-choice options, as these majors reach capacity after first-choice admissions.

## APPLICATION ELIGIBILITY REQUIREMENTS

Students must meet the following application eligibility requirements by the application deadline to be considered eligible to apply. Meeting these minimum requirements does not guarantee admission to a Terry BBA major; applicants will be evaluated based on specific selection criteria (see back page).

### ✓ ELIGIBLE FOR CURRENT ENROLLMENT AT UGA

- Applicants must be eligible for enrollment at UGA in the semester in which they apply to a Terry major.

### ✓ MINIMUM GPAs

- Applicants must be in “good academic standing” at UGA, meaning they must have a 2.0 or higher cumulative (UGA) GPA, or no cumulative GPA for a new transfer student.
- Applicants must also have a 2.6 or higher overall GPA (transfer and UGA coursework combined).

### ✓ MEET ONE OF THE FOLLOWING REQUIREMENTS DURING THE SEMESTER OF APPLICATION:

- Have completed or are in-progress of completing of [Areas I-V of the General Education Core Curriculum](#), OR
- Have a minimum of 58 credit hours completed or in progress of completion (not including P.E.)

### ✓ HAVE SUCCESSFULLY COMPLETED THE FOLLOWING COURSES:

- MATH 1113 – Precalculus
  - Course credit or an exemption for MATH 1113, MATH 2200, MATH 2250, or MATH 2260 is required.
- ACCT 2101 – Principles of Accounting I

### ✓ HAVE SUCCESSFULLY COMPLETED OR BE ENROLLED IN THE FOLLOWING COURSES:

- ACCT 2102 – Principles of Accounting II
- ECON 2105 – Principles of Macroeconomics
- ECON 2106 – Principles of Microeconomics
- LEGL 2700 – Legal and Regulatory Environment of Business
- MIST 2090 – Introduction to Information Systems in Business
- BUSN 3000 – Applied Statistics and Data Analysis for Business

### Important Reminders:

**Transfer Coursework:** Applicants should confirm that transfer courses are *direct equivalents* to the UGA courses required for application eligibility. Use UGA Admission’s [Transfer Equivalency tool](#) to check transfer course equivalency. If any of the required coursework has not been posted to your UGA transcript, proof of coursework must be attached to the application by the application deadline. Applicants who do not provide proof of coursework by the deadline will become ineligible.

**In-Progress Coursework:** In-progress coursework must be taken in the same semester in which students apply to a major (e.g., pre-registered summer courses will not satisfy eligibility requirements for spring admission cycle). Additionally, attendance in required courses must begin by the major application deadline each fall and spring (e.g., half-semester courses that begin after the major application deadline will not satisfy eligibility requirements).

**Withdrawals:** Students who withdraw from any required coursework *during the semester in which they apply* to a Terry major are at risk of having their major admission offer rescinded. Withdrawals that occur before the application semester will not be reported in a student’s application; however, such withdrawals may affect when a student is eligible to apply to a Terry major.

### Terry Direct:

UGA students in good standing with the Morehead Honors College who meet all eligibility requirements and apply to a Terry College of Business major are guaranteed their first choice of a first (primary) major. This guarantee does not apply to second, double or co-majors. Note that a condition for being in “good standing” with the Honors College includes completing at least one semester of coursework at UGA and earning a minimum cumulative GPA of 3.40.

# BBA MAJOR SELECTION CRITERIA

*What is considered for your Terry major admissions decision?*

## GRADES IN THE FOLLOWING COURSES:

- ✓ **ACCT 2101 & ACCT 2102**  
If ACCT 2102 is in progress, applicants will be evaluated based on their grade in ACCT 2101.
- ✓ **ECON 2105 & ECON 2106**  
If one of these courses is in progress, applicants will be evaluated based on their grade in the completed course.
- ✓ **MATH 1113**  
In addition, grades in MATH 2200, 2250, and 2260 will be evaluated, if completed.
- ✓ **BUSN 3000** (if completed)
- ✓ **Specific Prefix Courses**  
Earned course grades in the prefix of the major to which the student is applying can be considered, but are not required, for admission to the major. For example, if applying to the Real Estate major, grades in REAL courses (e.g., REAL 4000) can be considered. In addition, grades in the College's Foundation First courses (FINA 3000, MARK 3000, MGMT 3000) can be considered by all majors, if completed.
- ✓ **Foreign Language Courses – International Business (IB) Co-Major Applicants Only**  
IB co-major applicants must either be enrolled in or have completed the third (or higher) level of the same language (i.e., SPAN 2001). A minimum grade of B is required in each language course. Note: Applicants natively fluent in a language other than English may waive this requirement by completing a foreign language proficiency waiver. Waiving this requirement does not waive the required credit hours toward graduation.

## STANDARDIZED TESTING:

- ✓ **ACT/SAT**  
Applicants are required to submit ACT or SAT scores and sub-scores to the University before being considered for admission to a major in the Terry College.
- ✓ **E-Proficiency Profile**  
The E-Proficiency Profile (EPP; formerly ETS) is a standardized, multiple-choice assessment of the academic skills developed in General Education Areas I-IV of the core curriculum (reading, writing, critical thinking and mathematics).  
In addition to required ACT/SAT scores, applicants may also submit an EPP score if they believe their ACT/SAT scores do not represent their current performance level. Applicants who have not taken the ACT or SAT must take the EPP to be eligible to apply to a Terry major.  
Applicants can take the EPP a maximum of three times while a UGA student. Scores from all EPP attempts will be reported directly to the Terry College from UGA Testing Services, and the highest EPP score will be considered in a student's application.  
The E-Proficiency Profile is administered by UGA Testing Services; students can register online to take this exam at [testing.uga.edu](http://testing.uga.edu). A list of sample EPP questions is available [here](#).
- ✓ **Accounting Exam**  
All Accounting and Finance major applicants are required to submit an Accounting Exam score. This is a multiple-choice test covering the content of UGA's ACCT 2101 course.  
Applicants can take the Accounting Exam a maximum of three times while a UGA student. Accounting scores will be recorded in Athena, and the highest score will be considered in a student's application.  
The Accounting Exam is administered by UGA Testing Services; students can register online to take this exam at [testing.uga.edu](http://testing.uga.edu). A list of sample Accounting Exam questions is available [here](#).

## STATEMENT OF PURPOSE:

## BBA MAJOR APPLICATION ELIGIBILITY REQUIREMENTS

All UGA students who plan to pursue the BBA degree are initially admitted to the Terry College of Business as intended-business majors and typically apply to a Terry major during the second semester of their sophomore year. Students must meet the following application eligibility requirements by the application deadline to be considered eligible to apply; meeting these minimum requirements does not guarantee admission to a Terry BBA major. Students who withdraw from any of the below required courses are at risk of having their major admission offer rescinded.

- **Eligible for current enrollment at UGA:** Applicants are not required to be registered for courses ("currently enrolled") during the semester in which they apply, but they must be eligible for current enrollment at the University of Georgia.
- **Minimum GPAs:** Applicants must be in "good academic standing" at UGA, meaning they must have a 2.0 or higher UGA GPA, or no UGA GPA for a new transfer student. Applicants must also have a 2.6 or higher earned overall GPA (transfer and UGA coursework combined).
- **MATH 1113:** Applicants must have successfully completed or have earned an exemption for MATH 1113/E or a higher-level MATH course.
- **ACCT 2101:** Applicants must have successfully completed ACCT 2101/E/H.
- **BUSN 3000:** Applicants must have successfully completed or be enrolled in BUSN 3000/E/H.
- **Other Curriculum Requirements:** Applicants need to have completed or be in the process of completing the BBA General Education Core Areas I-VI, **OR** applicants need to have completed or be in the process of completing the BBA General Education Core Area VI and have a minimum of 58 hours completed or in progress (not including P.E.).

### Upper Division General Electives (9-12 hours depending upon major)

Choose any 3000-level or above Terry College prefix course(s)\* outside the major prefix. Students may also transfer any 3000-level or above business prefix course(s), other than the major prefix, but a minimum of 3 hours must be satisfied with a Terry College prefix course in residence at UGA. In addition, students may also choose any 4000-level or above course(s) other than a Terry College prefix.

### Arts & Sciences Electives (12 hours)

# TERRY COLLEGE OF BUSINESS AB ECONOMICS MAJOR ADMISSIONS PROCESS

All University of Georgia (UGA) students who plan to pursue the Bachelor of Arts (AB) in Economics degree are initially admitted to the Terry College of Business as intended-business majors. Students can apply to a Terry major once they meet all application eligibility requirements, typically during their second year at UGA.

The primary distinction between the AB Economics degree and the BBA Economics degree is that the AB provides a liberal-arts track through the major, while the BBA provides a professional track. The economics courses are the same; what differs is the set of courses that students take outside of Economics. The AB Economics degree is complementary to many other programs of study. Popular dual major choices outside the Terry College include International Affairs, Political Science, Statistics, Mathematics, and Computer Science. It's also not unusual for medical school aspirants to combine their science studies with an AB Economics degree. In general, students with interests that go beyond business-related courses should consider the AB degree because it offers greater flexibility and more elective options.

# TERRY COLLEGE OF BUSINESS AB ECONOMICS CURRICULUM CHECKLIST

## AB ECONOMICS MAJOR APPLICATION ELIGIBILITY REQUIREMENTS

All UGA students who plan to pursue the AB Economics degree are initially admitted to the Terry College of Business as intended-business majors and typically apply to a Terry major during the second semester of their sophomore year. Students must meet the following application eligibility requirements by the application deadline to be considered eligible to apply; meeting these minimum requirements does not guarantee admission to the AB Economics major. Students who withdraw from any of the below required courses are at risk of having their major admission offer rescinded.

- **Eligible for current enrollment at UGA:** Applicants are not required to be registered for courses ("currently enrolled") during the semester in which they apply, but they must be eligible for current enrollment at the University of Georgia.
- **Minimum GPAs:** Applicants must be in "good academic standing" at UGA, meaning they must have a 2.0 or higher UGA GPA, or no UGA GPA for a new transfer student. Applicants must also have a 2.6 or higher earned overall GPA (transfer and UGA coursework combined).
- **MATH 1113:** Applicants must have successfully completed or have earned an exemption for MATH 1113/E or a higher-level MATH course.
- **ECON 2105 & 2106:** Applicants must have successfully completed or be enrolled in ECON 2105/E/H and ECON 2106/E/H. AP and IB credit exemptions are also accepted.
- **BUSN 3000:** Applicants must have successfully completed or be enrolled in BUSN 3000/E/H.
- **Other Curriculum Requirements** Applicants need to have completed or be in the process of completing the AB Economics General Education Core Areas I-VI, **OR** Applicants need to have a minimum of 58 hours completed or in progress (not including P.E.).

## GUIDELINES FOR WRITING A SUCCESSFUL STATEMENT OF PURPOSE

As you prepare to apply to Terry, you are required to write a Statement of Purpose for each major to which you apply. You will need to describe your interest and future goals in a brief 300-400 word essay for your first and your second choice major.

This process can be frustrating and arduous if you are unsure of where to begin. Below you will find a few questions that you can ask yourself in order to make this process a little easier. Not all of these questions must be answered in your statement; they are just questions to get your mind rolling and your pen moving!

- What meaning have you drawn from your business courses so far? How do they influence your major choice?
- What aspect of your major course of study attracts you?
- What goals have you set for yourself professionally? How is a Terry degree going to help you attain these goals?
- Why is Terry College the place for you?
- What professional experience do you have already?
- What will make Terry College say, "Yes, let's pick this student?"
- Is there anything special/interesting about you that would help you stand out?

- Be respectful
- Remember this is a professional statement—you should polish your writing
- Writing needs to be grammatically correct
- Always check for spelling errors
- Consider your audience
- Ask for help when needed

## MAXIMIZING YOUR EPP SCORE

The E-Proficiency Profile (formerly known as the ETS) is a standardized, multiple choice assessment of the academic skills developed in General Education AREAS I-IV of the core curriculum (reading, writing, critical thinking, and mathematics). Only applicants who do not have ACT/SAT scores are required to take this test.

**FOR MOST HIGH DEMAND MAJORS**, students should aim to score a **480** out of **500**.

*However, no EPP score guarantees admission to a Terry major.*

## INFORMATION ABOUT THE EPP

---

- Students can register online at the University Testing Services Website (<https://testing.uga.edu/>) or call 706.542.3183
- Test can only be taken a total of three times; scores are directly reported to Terry College
- Cost: \$53.50 (can be paid in advance or at the time of your test)
- Students should bring their **UGA ID** or a legal photo ID
- Students can bring a 4-function calculator, non-graphing, or scientific calculator
- Student will have **40 minutes** to complete **36 questions**
- Students should allocate at least an hour in their schedule to complete the test

## PREPARATION STRATEGIES

---

- Practice SAT test-like questions under test-like conditions
- Review grammar rules and handbooks (numerous online resources)
- For reading comprehension, search for and practice TOEFL reading test questions
  - This is helpful for native speakers and ESOL students
- For math, practice problems related to rate, percentages, fractions, and algebra
  - Be especially mindful of change in rate problems (time, money, temperature)
  - Watch for rate changes within a problem
